Item 5.07 Submission of Matters to a Vote of Security Holders.

On September 30, 2022, the Annual Meeting of Shareholders (the "Annual Meeting") of Cemtrex Inc. ("Centrex" or the "Company") was held. For more information about the proposals set forth, please see the Company's 2021 Proxy Statement. On the record date of August 17, 2022, there were 26,413,296 shares of the Company's common stock issued, outstanding and entitled to vote, 4,030,044 votes of the Company's Series 1 Preferred Stock, and 264,397,093 votes of the Company's Series C Preferred Stock held by Saagar Govil, CEO and Chairman of the Board of Directors of the Company, for a total of 294,968,633 voting shares. At the Annual Meeting, a total of 279,681,476 voting shares (for a quorum of 94.82%) were represented in person or by proxy at the meeting. Set forth below are the final voting results for the proposals voted on at the Annual Meeting.
